Temporary Closure of Knole Causeway

TAKE NOTICE that in pursuance of Section 14(1) of the Road Traffic Regulations Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, the County Council of Somerset propose to make an Order **PROHIBITING ALL TRAFFIC** from proceeding along **Knole Causeway** from **outside the property named The Old Hay Barn** to **outside the property named Ciderpress Farm** a distance of **200 metres**.

This order will enable Wessex Water to carry out sewer renovation works in this road.

The Order becomes effective on **22 November 2017** and will remain in force for eighteen months. The works are expected to last for **2 days**. While the closure is in operation an alternative route will be signed as detailed below.

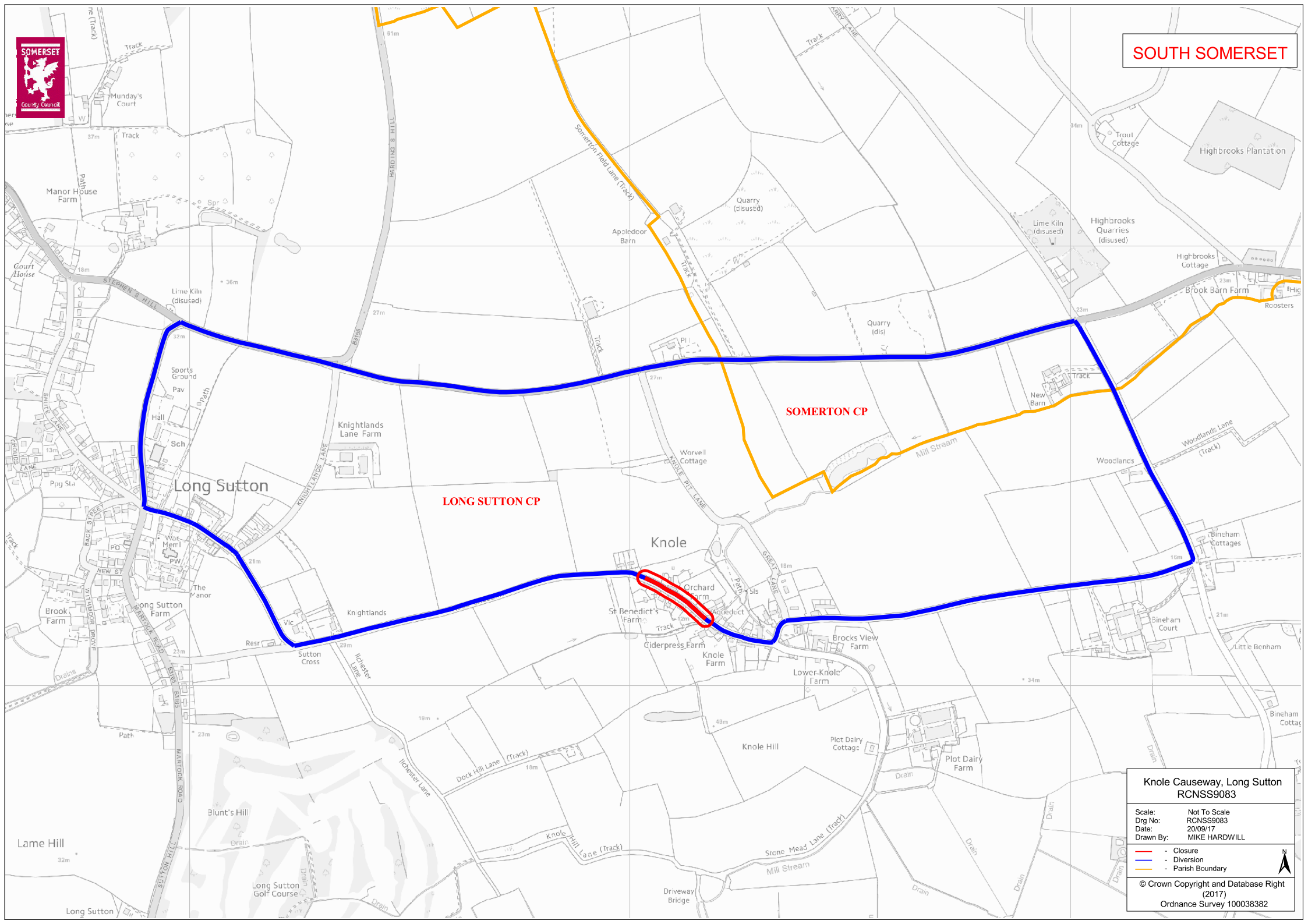
